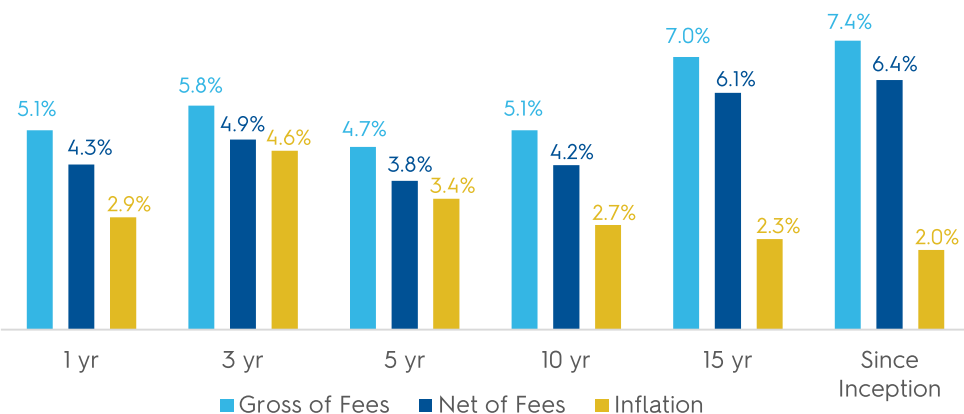
COMPOSITE OVERVIEW

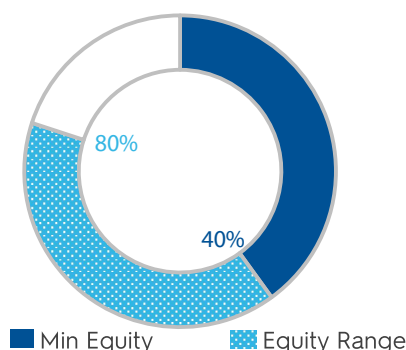

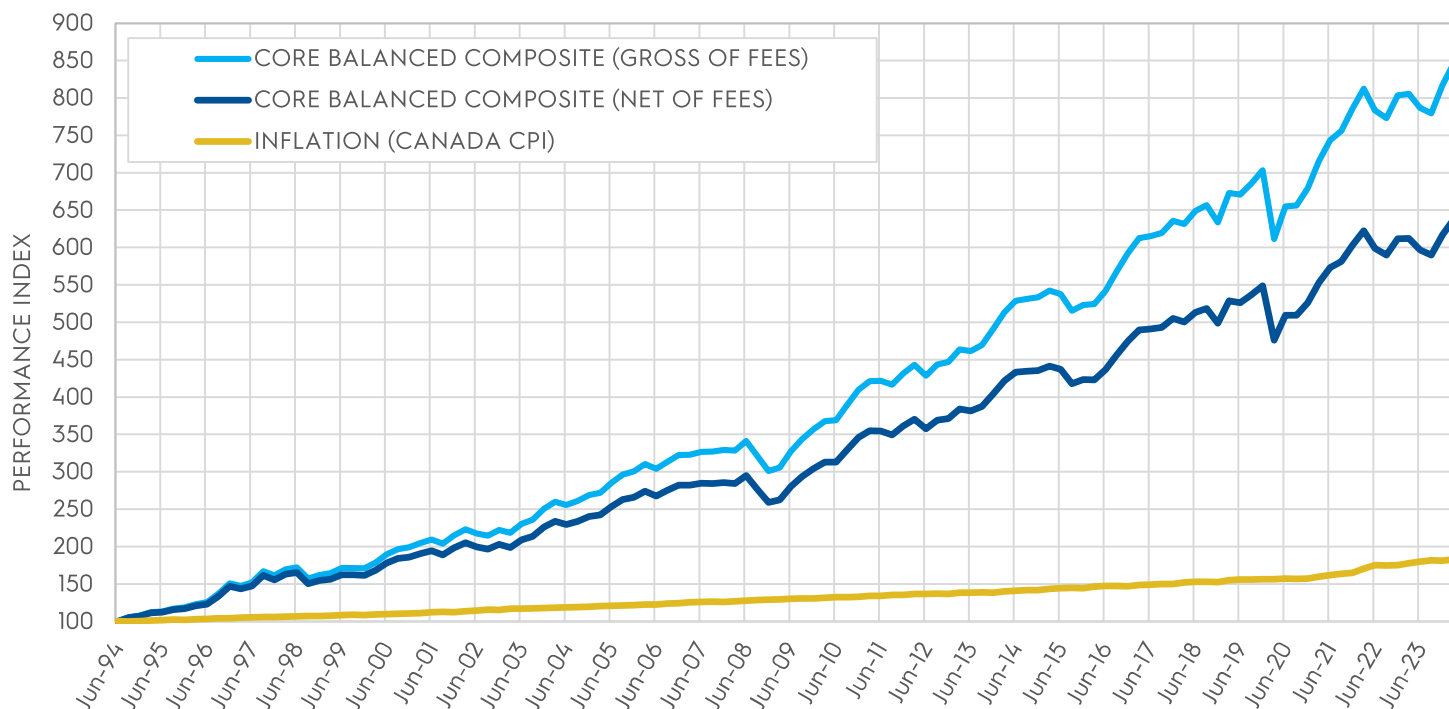
Annualized Returns (%) in Canadian Dollars
