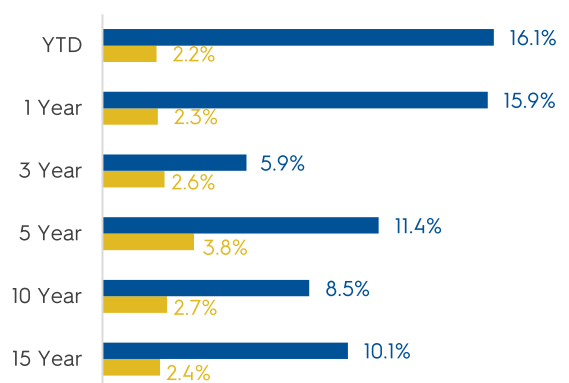
POOLED FUND OVERVIEW

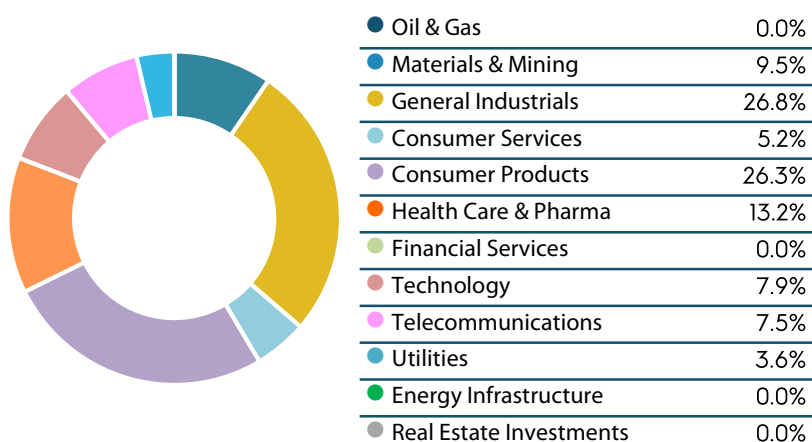
Annualized Returns (%) in Canadian Dollars



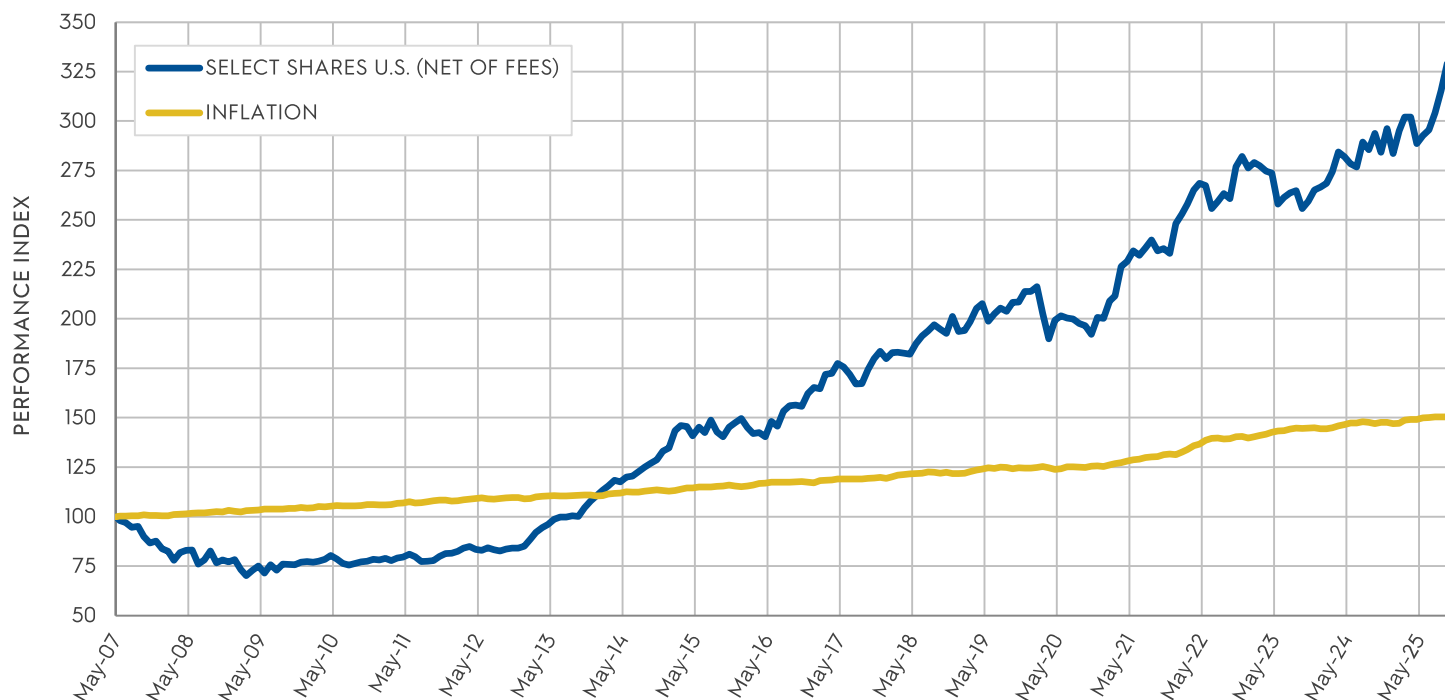
■ SELECT SHARES U.S. (NET OF FEES) ■ INFLATION
